<b>Licence:</b>	Permission to use the quality label.
<b>Approval (P-No.)</b>	Confirmation that a specific manufacturer's product (powder coating, liquid coating or chemical product) meets the requirements of the QUALICOAT Specifications.
<b>General Licensee (GL):</b>	National or international association holding the QUALICOAT general licence for a defined territory.
<b>Testing laboratories:</b>	Independent quality testing and inspection bodies duly authorized by the General Licensee or QUALICOAT.
